Green diagnostic LED

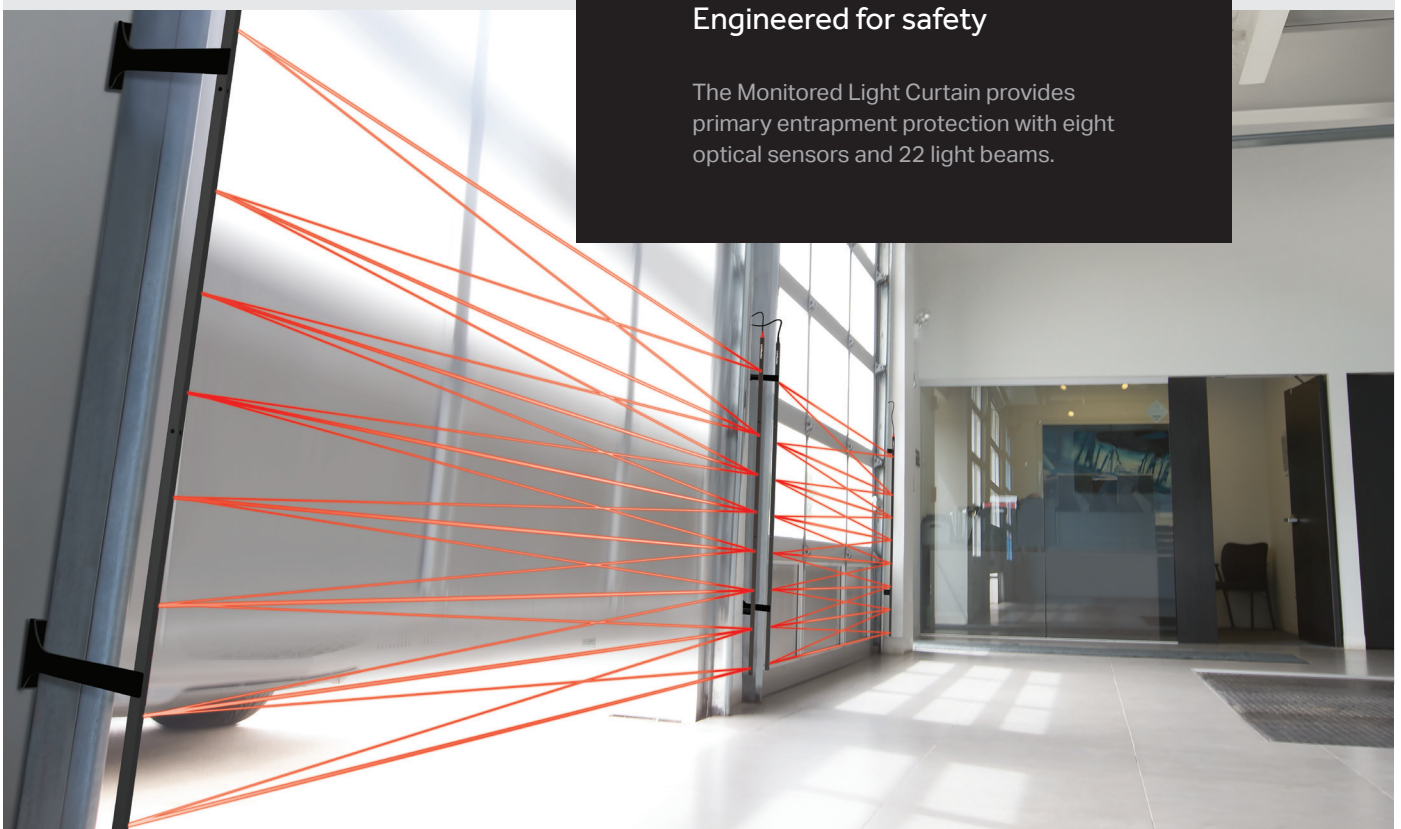
Flashes when interrupted, providing visible interrupt detection.

Seamless door system

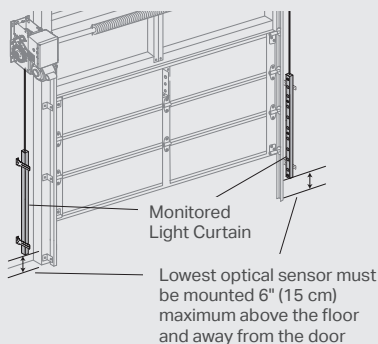

Installation Options

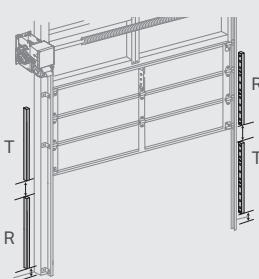
The proper installation and use of appropriate entrapment protection sensors reduces the occurrence of accidents and the exposure of installers and customers to liability.

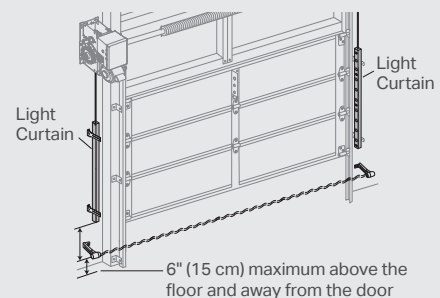

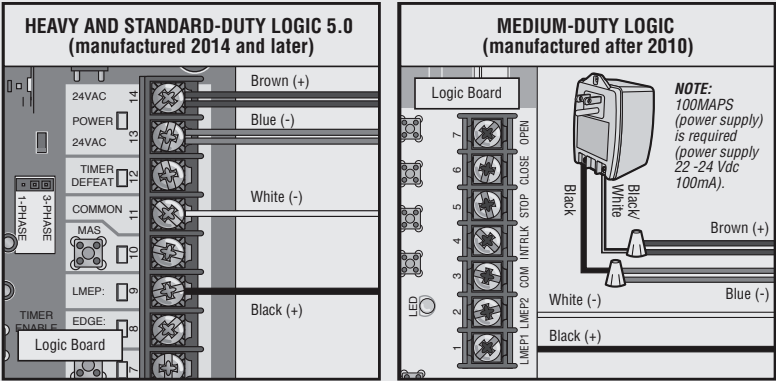
